It was MOTIONED by **MITCHELL L. LEWIS.** and SECONDED by **MARY L. GREEN** to approve the minutes of the **February 8, 2016** *regular* City Council meeting and to dispense with the reading. Motion Passed Unanimously.

The City Clerk next opened the floor to hear public comments from those in attendance to any item outlined on the meeting agenda. When <u>no</u> comments were offered from the floor, the **Public Comments Period** was then closed.

New Business:

Item A: The city clerk introduced **Ordinance No. 1 of 2016** drafted to change zoning on property municipally known as 107 McEnery Street from a B-3 District (Community and Central Business District) to an R-2 District (Multi-Family Residence District). The property is more particularly BEG 301.6 FT W OF INTERSECTION OF S/L MCENERY ST WITH W/L WASHINGTON ST AT NW COR J. A. JACKSON LOT, TH W ALONG S/L MCENERY ST 100 FT, TH S 200 FT, W 102 FT, S 220 FT, E ALONG SCHLEY ST 202 FT, N 420 FT TO BEG, LESS LOTS (159-575)(250-442)(487-895)(513-142)(522-145,504)(643-35)(663-96). SEC 16 T12 R13 (728-647)(880-763)(891-857). Property owners **David** and **Mattie Vcelik** submitted a Change of Zoning request form (and other required documents) to the Mansfield Planning and Zoning Commission for discussion at their regular meeting held on Wednesday, February 17th. The Vcelik's petition made clear that the property would be used for residential purposes. The petitioner's request was approved by the Zoning Commission and a recommendation was made to have same placed on an agenda of the City Council for further consideration. It was MOTIONED by MARY L. GREEN and SECONDED by JOSEPH HALL, JR. to authorize advertisement of the title of Ordinance No. 1 of 2016 on March 3, 2016, and set a public hearing on same for March 14, 2016. Passed Unanimously.

Item B: It was MOTIONED by **KERVIN D. CAMPBELL** and SECONDED by **MARY L. GREEN** to authorize advertisement for sealed public bids for the 2014/2015 LCDBG Sewer Rehabilitation Improvements Project. All sealed bids received will be opened on March 23rd, taken under advisement and tabulated by our consulting engineering firm (BALAR Associates, Inc.).
