MINUTES OF *REGULAR* PUBLIC MEETING
January 11, 2016

The Board of Aldermen met in regular session on **Monday, January 11th** in Mansfield City Hall located at 705 Polk Street. Mayor McCoy called the meeting to order at **4:30 p.m.**, after which an Invocation was offered by **Alderman Joseph Hall, Jr.** The Pledge of Allegiance was led by **Alderwoman Mary L.
