## City of Mansfield MINUTES OF *REGULAR* PUBLIC MEETING March 27, 2017

The Board of Aldermen met in regular session on **Monday, March 27**th in Mansfield City Hall located at 705 Polk Street. Mayor Curtis McCoy called the meeting to order at **4:30 p.m.**, after which an Invocation was offered by **Alderwoman Mary L. Green.** The Pledge of Allegiance was led by **Alderman Kervin D. Item A: It was MOTIONED by MARY L. GREEN and SECONDED by JOSEPH HALL, JR. to approve the Resolution on page 17 of the Municipal Water Pollution Prevention (MWPP) Environmental Audit Report. Contained in each alderman's agenda package was the annual MWPP for their review. After review and a brief discussion, the council was asked to adopt the Resolution on page 17 as mandated by the Louisiana Department of Environmental Quality (DEQ) in order to maintain requirements for the city's Permit Number LA0038962. The Resolution recites certain assurances made by the Board of Aldermen with regard to the actions taken by them in maintenance of permit requirements contained under the city's permit number. Motion Passed Unanimously.

**Item B:** It was MOTIONED by **MITCHELL L. LEWIS** and SECONDED by **KERVIN D. CAMPBELL** to approve the recommendation of Fire Chief, LaTarsha Shelton, to offer full-time employment to Mr. **JaRoderick R. Claiborne** with the Mansfield Fire Department. Mr. **Claiborne** has been employed with the Fire Department since <u>November 16, 2016</u>, and since his tenure with the Department, has performed his duties exceptionally well. Also, Mr. Claiborne has completed his first level of training required for employment. He reports to work on time and can be counted on to perform certain tasks without being told.
